

Competition Terms and Conditions

1. Introduction

By entering this competition, participants agree to be bound by these Terms and Conditions. The competition is organised by Hare & Forbes Machineryhouse.

2. Eligibility

- 2.1. The competition is open to Australian residents aged 18 years or older.
